Description	General Dynamics Mission Systems is seeking a supplier to design and build a hydrostatic tester to perform automated pressure testing of cabinets, hoses, connectors and two flow switches. Supplier will base their design upon a specification, parts list and test procedures to be provided by General Dynamics.
	It is presumed that the hydrostatic tester will be "automated' to the maximum extent possible, using an industrial computer and a suitable user interface. This automation will allow a modestly skilled operator to test the various flow and pressure regimes and when required, monitoring the state (i.e. open or close) of the flow switches. The system will be cable of performing a hydrostatic test "self- test" before testing. The system will use either stainless steel and/or suitable engineering plastic for all wetted parts. The working fluid is distilled water.
